- 1. <u>Purpose</u>. To establish policies and procedures concerning the implementation of the Commander, Navy Region Europe, Africa, Central (CNREURAFCENT) Qualified Recycling Program (QRP) in accordance with the provisions of references (a) through (g).
- 2. Cancellation. NSABAHRAININST 5090.1C.
- 3. <u>Background</u>. Recycling is a series of activities by which materials that would become or otherwise remain waste are diverted from the solid waste stream by collection, separation, and processing. These raw materials are subsequently used in the manufacture of goods sold or distributed in commerce or reused as substitutes for goods made of virgin materials. A QRP is designed to reduce waste, prevent pollution, and conserve material resources.

4. Policy

- a. QRP materials are directly sold for recycling purposes. Revenues generated from the sale of recyclable materials are deposited into a QRP account through the U.S. Treasury. Per reference (b), proceeds will be distributed as follows:
- (1) Initial proceeds from the QRP will be used to cover operation, maintenance, and overhead costs for processing recyclable material, including the cost of equipment purchased for recycling purposes.
- (2) Up to 50 percent of any remaining balance will be used for pollution abatement, energy conservation, and occupational safety.

- (3) The remaining balance may be transferred to the Morale Welfare and Recreation non-appropriated fund account at CNREURAFCENT or maintained in an F3875 Suspense Account. At the end of the fiscal year, any balance over \$2 million in the QRP account will revert to the U.S. Treasury.
- b. Recyclable material consists of materials diverted from the solid waste stream that are not contaminated with food or hazardous materials. Naval Support Activity, Bahrain collects the following recyclable materials, but are not limited to:
 - (1) Mixed paper (Including shredded paper except pulverized)
 - (2) Newspaper
 - (3) Cardboard
 - (4) Plastic (shopping/grocery bags, plastic bubble wrapped polyethylene bottles, styrofoam, etc.)
 - (5) Metal cans
 - (6) Used oil (except when hazardous)
 - (7) Lead-Acid batteries
 - (8) Scrap metal (ferrous and non-ferrous)
 - (9) Firing range expended brass and mixed metals
 - (10) Toner cartridges
 - (11) Aluminum
- c. Excluded materials or non-recyclable materials include precious metal-bearing scrap and items that may be used for their original purpose or function without special processing. These materials will be turned in to the Defense Logistics Agency (DLA), Disposition Services for processing. Excluded materials may not be sold through a QRP and include, but are not limited to:
 - (1) Government-furnished material
 - (2) Precious metal bearing scrap
 - (3) Hazardous material

- (4) Ozone Depleting Chemicals
- (5) Electrical components
- (6) Unopened containers of solvents, paints, or oil
- (7) Used tires
- (8) Material that can be sold (as is) as a usable item
- (9) Repairable items that may be used again for their original purpose or function, e.g., used vehicles, vehicle or machine parts, etc.
- (10) Ships, aircraft, weapons and other material required to be demilitarized and resulting scrap.
- (11) All munitions list items and strategic list items as defined in reference (c) except firing range expended brass and mixed metals gleaned from firing range cleanup.
- (12) Surplus personal property whose sale proceeds must be deposited to accounts other than a QRP per 32 CFR 172, Appendix B, are:
 - (a) Scrap generated from Defense Business Operations Funds (DBOF) activities
 - (b) Usable personal property purchased by DBOF activities
 - (c) Property purchased with commissary surcharge funds
 - (d) Automatic data processing equipment owned by Government Services Administration
 - (e) Property purchased for the Military Assistance Program
 - (f) Property purchased with Foreign Military Sales funds
 - (g) Coast Guard property
 - (h) Property owned by non-appropriated fund activities
 - (i) Lost abandoned, or unclaimed privately owned personal property
 - (i) Property owned by another country or international organization
 - (k) Bones, fats, and meat trimmings generated by a commissary

5. Action

- a. The Environmental Department will promote and publicize the QRP and is responsible for the overall management of the program, including collection, sale and distribution of recyclable materials, expenditure of funds, and accounting.
 - b. NSA Bahrain facilities and tenant commands will actively participate in the QRP.
- 6. <u>Records Management</u>. Records created as a result of this instruction, regardless of media and format, must be managed per Secretary of the Navy Manual 5210.1 of January 2012.
- 7. Review and Effective Date. Per OPNAVINST 5215.17A, NSA Bahrain will review this instruction annually on the anniversary of its effective date to ensure applicability, currency and consistency with Federal, DoD, Secretary of the Navy and Navy policy and statutory authority using OPNAV 5215/40 Review of Instruction. This instruction will be in effect for 10 years after effective date unless reissued or canceled in the interim and will be reissued by the 10-year anniversary date if it is still required, unless is meets one of the exceptions in OPNAVINST 5215.17A, paragraph 9.
