1. <u>Purpose</u>. Per reference (a), the following timeline is published to direct submission and boarding of E-7 and officer detachment of reporting senior performance evaluations.

17 May 23	Evals/FITREPS due to Admin for review/signature
26-30 June 23	Debriefs
7 July 23	Signed evals mailed to PERS 32

- 2. All evaluations must be submitted physically and digitally to Admin using NavFit98A, per reference (b). Submit evaluation reports with all previous evaluation reports from this command or transfer evaluation report, PRIMS data sheet, member data summary sheet from FLTMPS, a copy of awards/school/qualifications received/completed for this time, and evaluation summary sheet, also known as a brag sheet.
- 3. Block 28 (Command Employment): CNIC installation providing support and security to NATO, C6F, forward deployed ships, aircraft, joint and coalition forces, 55 tenant commands, and 10,000 assigned personnel for facilities, military readiness, and command and control across the C6F AOR.
