Prepares and distributes a summarization of the minutes to committee members. Uploads the minutes electronically on the committees' folders on the Share Drive and keeps a minute's hard copy on file. Schedules committees' meetings as directed by chairs and notifies committees' members by email and online meeting invitations. Manages the Operating Target Budget (OPTAR) for the Director of Surgery and orders office supplies, ensuring a sufficient level of office supplies is maintained. Provides advice and assistance with the preparation of correspondence, format, presentation, routing of information/instructions in order to be aware of new, revised, or amended procedures including reports, forms, filing and mail procedures. Reads outgoing correspondence for procedural and grammatical accuracy. Reads and reviews material to be filed, ensures document is complete before filing. Retrieves files based on knowledge of filing system. Maintains and purges files. Sets up and maintains logs depicting the status of actions. Makes pen and ink changes to official manuals. Processes performance evaluations on all officers, enlisted and civilian personnel as directed by the Directors.
