At the full performance level, the incumbent is responsible for the acquisition, management and disposal of real estate and real estate interests as dictated by the Naval Facilities Engineering Command (NAVFAC) Real Estate Business Line. Provides a variety of real estate products and services, to include lease administration, special studies and consultations. Makes recommendations concerning competition, market surveys, negotiation of offers and lease terms. Prepares lease contracts, obtains funding documents and submits leases to the Real Estate Contracting Officer for signature. Initiates, tracks and coordinates all actions relative to a project (new leases, succeeding leases, lease modifications). Replies to inquiries of real estate matters, prepares written reports identifying problem areas and makes recommendations for their resolution. Performs a wide range of real estate lease administration duties, including filing and project management. Maintains a real estate tracking system to track renewals, notifies customers of upcoming lease renewal requirements and ensures accurate funding is received on time. Works with multiple currencies and must keep track of NAVFAC budget rates of exchange. Performs written translations of a wide range of real estate documents to include leases, lease modifications, technical specifications, and general correspondence.

# **QUALIFICATION REQUIREMENTS**
