The incumbent is a technical expert as it pertains to the entry control team which is responsible for conducting commercial, private and government vehicle screening and passenger identity checks. Conducts I.D. checks at access points to NSA Naples Installations. Conducts inspections of vehicles and hand carried bagged for contraband prior to personnel being authorized access to designated areas, and conducts high Traffic in the morning. Controls the movement of persons and protect lives and personal property and critical national strategic assets in and around Navy property being protected. Uses approved communication equipment to immediately contact the installation security forces (law enforcement) in order to transfer any person suspected of a violation of good order and discipline. Must possess the knowledge, skill, ability and responsibility to apply and utilize specialized access control equipment (e.g., automated gate systems, pop-up barricades and bollards, explosive detection equipment, credential verification systems). Applies appropriate Rules Of Engagement (ROE) and Rules for Use of Force (RUF), to include deadly force, based on the determination of hostile intent. Acts as an interpreter/translator when required, and also due to the cooperation with the additional workforce force of the Italian Air Force. Monitors all traffic and parking infractions throughout all NSA Naples facilities. Assists Security Department during times of need when translations with local nationals, to include law enforcement personnel, are necessary. Assists emergency situations involving U.S. military and/or government employee, operates radio and telephone equipment to coordinate the response of the multiple local emergency units driving to the emergency, utilizing acquired skills, experiences and good judgment. Relays vital force protection information to proper local authorities and prioritizes calls for service.
