Assists in the formulation/execution of budgets to support plans, programs, and projects. Extracts information from various documents/database to prepare financial status reports. Analyzes financial/operational data using statistical method to assess financial program control/management effectiveness and efficiency. Applies a wide range of analytical techniques/processes to assure funds are not under or over obligated and are spent in a timely manner. Uses various automated financial management systems and computer programs to prepare funding documents and create graphs/charts/spreadsheets to accomplish assigned duties and responsibilities. Manages Automated Travel Program System ensuring proper submission of travel requests and reimbursement vouchers. Manages Government Travel Credit Card Program. Provides assistance to card holders on proper use of cards, closely monitoring potential fraud and abuse. Works with internal and external customers to accomplish command's goals and mission.
