#### **INTRODUCTION:**

The purpose of the position is to perform a variety of tasks including taking orders for food alcoholic drinks, serving cocktails and drinks, operating a Point of Sale cash register, providing customer service. The employee is also responsible for the efficiency, cleanliness and appeal of the bar area during specific work shift.

#### **DUTIES AND RESPONSIBILITIES:**

Takes customers' orders for fast foods, snacks and drinks using a point-of-sale cash register. Serves a variety of alcoholic beverages or liqueurs and mixes internationally known cocktails. Takes payments, makes change and provides receipts. Monitors patrons' alcohol consumption and may withhold serving drinks, if warranted, or notifies the supervisor of customers' apparent intoxication.

The employee strives to insure consistent preparation, delivery and presentation of drinks and food; insures customers are completely satisfied and refers any customer service issues to the supervisor for resolution.

Maintains counter spaces and work area in clean condition and orderly fashion. Insures spills and/or dropped food are removed quickly to prevent safety hazards and sanitation procedures are handled according to established standards for beverages and food.

May clear and clean dining tables, and dispose of food waste and trash left on tables. May assist with unloading/loading deliveries from warehouse into storage areas.

**QUALIFICATION REQUIREMENTS:**

Applicants must show through their experience and/or training that they can satisfactorily perform the above stated duties under normal supervision.

**KNOWLEDGE REQUIRED BY POSITION:**

Knowledge of alcoholic beverages, standard mixes and skill in their preparation, using correct proportions, in a fast and efficient manner.

Ability to operate a cash register.

Skill in handling customers and duties simultaneously.

Selectee will be required to favorably pass a security background check and a pre-employment medical suitability examination as a condition of employment.
