Department of the Navy provides competitive salaries, comprehensive benefits, and extensive professional development and training.

MAJOR DUTIES AND RESPONSIBILITIES: Food Service Workers perform a variety of food preparations and limited cooking tasks in a club and/or snack bar environment. Assist higher level food service worker or cook to perform a variety of tasks such as grilling/frying food, by watching while the items are cooking, turning as required, regulating temperature and removing when done to specified temperature. Measure and weigh ingredients according to recipes or as directed in the preparation of salads, desserts, juices, fruit trays, etc. prepares vegetables and fruits for serving according to instructors and/or recipes. Prepare pizzas to specific recipes. May be required to provide barista services and prepare and serve beverages. Plate food for presentation to guests in accordance with instructed procedure/specifications.

Washes and cleans kitchen equipment and work area. May be required to collect money, operate a cash register and prepare Daily Activity Report for cash accountability for MWR funds received. May assist in taking monthly inventory. May assist with outdoor MWR functions.

KNOWLEDGE REQUIRED BY THE POSITION: Applicants must have a minimum of six months of general experience which demonstrates the ability to perform the above stated duties. Must be able to follow recipes and combine/measure/weigh ingredients. Must be knowledgeable on food handling, food presentation and accepted hygiene practices. Must be able to read/write/converse in English. Must have or obtain within 30 days alcohol server certification and the Food Handlers Certification to be updated and maintained annually. Ability to satisfactorily complete background check which includes National Agency Check with Written Inquiries (NACI). In addition to the above, selectee will be required to pass a physical examination. Ability to communicate effectively in English, both orally and in writing. Ability to follow verbal and written instructions. Ability to complete all DoN training requirements within the specified time frames. Ability to work cooperatively as a member of a team.

CONDITIONS OF EMPLOYMENT: Must pass a pre-employment physical, provide evidence of immunization and be free from communicable disease.

Incumbent must satisfactorily complete all background checks for federal positions, including a National Agency Check with Inquiries (NACI), criminal history checks to include fingerprints.
