Subj: DESIGNATION AS INDEFINITE OFF-LIMITS ESTABLISHMENTS/AREAS

Ref:

(a) OPNAVINST 1620.2A

(b) COMNAVREGEURAFSWAINST 1620.5 (c) NAVSUPPACT BAHRAININST 1620.1E

- 1. <u>Purpose</u>. To establish indefinite off-limits areas in accordance with references (a) through (c), the following locations are designated as indefinitely off-limits:
 - (a) Annesco Tailoring;
 - (b) Thai Massage Salon and Spa (Formerly Beijing Massage Hair Dressing Salon);
 - (c) Pars Hotel and all restaurants/bars on the premises;
 - (d) Monroe Hotel and all restaurants/bars on the premises;
 - (e) Raagam Textiles in the Manama Souk;
 - (f) Cavallos Atiram Premier Hotel;
 - (g) Club LiV Juffair Gate Hotel:
 - (h) Déjà vu Block 338, Manama, Bahrain.

2. Cancellation. NAVSUPPACT BAHRAINNOTE 5800.4B

- 3. <u>Policy</u>. A change in ownership, management, or name does not impact the designation of any of these establishments as off-limits. This letter applies to all armed forces personnel and Department of Defense personnel in the Kingdom of Bahrain. In accordance with reference (a), an establishment may petition the President of the Armed Forces Disciplinary Control Board to remove the off-limits restriction. The petition must be in writing and include a detailed report of action taken to eliminate the condition or situation that caused imposition of the restriction. This letter nullifies all previous letters designating establishments indefinitely off-limits in Bahrain.
- 4. <u>Lawful Order</u>. This notice is a lawful order, and violators may face disciplinary action under the Uniform Code of Military Justice.
- 5. <u>Records Management</u>. Records created as a result of this notice, regardless of media or format, must be managed per Secretary of the Navy Manual 5210.1 of January 2012.
