- 1. <u>Purpose</u>. To provide guidance to the U.S. Naval Support Activity (NAVSUPPACT), Naples, Italy, Command Duty Officers (CDO), tenant command Commanding Officers (CO), Officers in Charge (OIC), and other designees on events requiring notification to the NAVSUPPACT

Naples Installation Commanding Officer (ICO) and if required, further notification to Commander, Navy Region Europe, Africa, Central (CNREURAFCENT) and Commander, Navy Installations Command (CNIC) leadership.

3. Discussion

- a. Reference (a) establishes Navy-wide guidance, policy, and reporting instructions on Special Incident Reporting (OPREP-3) requirements of critical situations and military operations and includes specific reporting requirements for several types of incidents. References (b) and (c) delineate specific safety-related event reporting requirements. Reference (o) provides CNIC Critical Information Requirements and Significant Event Reporting guidance. References (p) and (q) provide Commander, Naval Forces Europe, Africa, reporting requirements, respectively. The reporting requirements contained in this instruction are in addition to, and not a substitute for, those contained in references (a) through (l) or other instructions that require separate reporting. Reference (t) is the CNREURAFCENT notification.
- b. CO, NAVSUPPACT Naples provides support to seven areas within its area of responsibility (AOR). CO, NAVSUPPACT Naples also has a responsibility to provide timely situation awareness reporting to CNREURAFCENT, CNIC, and tenant command leadership regarding events involving installation operations both directly and indirectly. This reporting supports decision-making and CNREURAFCENT notification.
- c. Commander's Critical Information Requirements (CCIRs) are key elements of information that directly affect the CO, NAVSUPPACT Naples decision-making process and require immediate notifications to him. Significant Event Reporting (SERs) are primarily for situational awareness and do not require immediate notification to the Commander and are provided at the daily morning turnover brief with the NAVSUPPACT Naples, Executive Officer (XO).
- d. This instruction cannot discuss every possible event requiring NAVSUPPACT notification. The NAVSUPPACT Naples CDO will use sound judgement to appropriately catalog events and make appropriate notifications not only to NAVSUPPACT, but also informing NAVSUPPACT tenant command COs and OICs or their designated representatives and NAVSUPPACT N-Codes or Department Heads when appropriate.
- e. Reporting of incidents and conditions requiring notification to the Regional Commander (REGCOM) are divided into three categories of information with corresponding means of dissemination by the Regional Operations Center (ROC): CAT I CCIR (immediate voice report and immediate amplifying e-mail), CAT II CCIR (immediate email), CAT III SER (routine email). Email reports should be both timely and provide as complete a situation picture as possible. Reports should include who, what, when, where, why, mission impact, and likelihood of media interest in a standard format; however, the need for complete information must be balanced with timeliness of the report. Amplifying information must also include ongoing action and impact to missions of the installation, operational forces, and/or tenant commands.

- f. When doubt exists as to whether an incident meets reporting definitions and criteria of this instruction, the event must be reported. When doubt exists as to the appropriate categorization of an event, report the incident as the higher category.
- g. Each CCIR or SER may require Standard Requests For Information (SRFI) when reporting. Reporting must not be delayed if SRFIs are not initially known, but will be answered as soon as available and prior to closing out the CCIR or SER.
- 4. <u>Policy</u>. This instruction provides guidance and direction for all NAVSUPPACT Naples CDOs and tenant commands COs and OICs during the execution of operations throughout all CCIR activation levels.

5. Responsibilities

- a. The NAVSUPPACT Naples CDO and NAVSUPPACT Naples Emergency Operations Center (EOC) will ensure timely notification and reporting of all incidents meeting CNREURAFCENT CCIR (e.g., terrorist attack, explosives events, natural disasters, severe weather or other events impacting operations or the Navy Family) and to coordinate responses with Navy, Department of Defence (DoD), and other governmental agencies.
- b. NAVSUPPACT tenant command COs and OICs must notify the NAVSUPPACT Naples CDO through their direct representative on events affecting their commands meeting the reporting requirements listed in this instruction and reference (p).
- c. NAVSUPPACT Naples Executive Officer (XO) will provide specific voice notifications to CO, NAVSUPPACT Naples.
 - d. NAVSUPPACT Naples Operations Officer (OPSO).
- Conduct an annual review and update, as required, of this instruction and the included CCIRs.
- (2) Provide voice notification to CO, NAVSUPPACT Naples in the absence, or unavailability, of the NAVSUPPACT Naples XO.
- (3) Train NAVSUPPACT Naples EOC and NAVSUPPACT Naples CDO personnel in the reporting guidance contained in this instruction and in the use of all available reporting mechanisms.
- e. The Senior Watch Officer (SWO). Train CDOs all watchstanders on the execution and implementation of all incidents (e.g., terrorist attacks, explosive events, natural disasters, severe weather or events impacting operations or the NAVSUPPACT Naples supported community).
 - f. The NAVSUPPACT Naples Command Duty Officer (CDO) must:

- (1) Immediately report all CAT I CCIR events via voice to NAVSUPPACT Naples OPSO, NAVSUPPACT Naples XO, and NAVSUPPACT Naples CO. Under no circumstances should the CDO delay notifying NAVSUPPACT Naples CO due to the unavailability of either the NAVSUPPACT Naples OPSO or NAVSUPPACT Naples XO.
- (2) Report CAT I and CAT II CCIRs electronically via email to NAVSUPPACT Naples CO, NAVSUPPACT Naples XO, and NAVSUPPACT Naples OPSO. When applicable, notify NAVSUPPACT Naples Command Master Chief (CMC), other NAVSUPPACT Naples N-codes and/or Special Assistants when the circumstances affect their area of expertise.
- (3) Report CAT III SERs in due course at the next morning turnover brief with the NAVSUPPACT Naples XO.
- (4) In all cases where a Higher Headquarters CCIR reporting requirement has been met, NAVSUPACT Naples CDOs will notify NAVSUPPACT Naples XO and CO for concurrence prior to making the report.

Note: For CAT I and CAT II CCIRS, if one or more SRFIs are unavailable, report "unknown at this time". Do not delay the report.

(5) Enclosure (1) provides the template for the voice report. Enclosure (2) provides the template for the email report. Enclosure (3) provides a quick reference list of all CCIRs by category.

6. Reporting Requirements

- a. <u>CAT I CCIR Immediate Voice Report and Immediate Email</u>. The NAVSUPPACT Naples CDO will immediately report, without delay, and regardless of the hour, the following CCIRs by voice report to the NAVSUPPACT Naples CO, NAVSUPPACT Naples XO and OPSO, NAVSUPPACT Naples. Initial voice reports are followed by an email with minimal delay.
- (1) Attack or Active Shooter on NAVSUPPACT Installation or Facility. Confirmed or unconfirmed attack or active shooter (or credible indications of an impending attack) against or onboard any NAVSUPPACT Naples installation or facility. (Examples include firearms, knives, weapons, detonation of bomb or improved explosive device (IED)).

(2) <u>Force Protection Condition Increase</u>. Any increase in Force Protection Condition (FPCON), Defense Readiness Condition (DEFCON), or Information Condition (INFOCON) that impacts a NAVSUPPACT installation. <u>Increases due to exercises or training are excluded from reporting</u>. Both ordered and attainment reports are required. This includes temporary condition increases made in immediate response to an incident, such as "lock-down" or "shelter-in- place." (Examples are European Command (EUCOM) directs all DoD installations to set FPCON C or ICO).

(5) <u>Combat Engagement</u>. Any attack with in the NAVSUPPACT Naples AOR involving the United States or combat engagement between U.S. Forces and any adversary not due to operations already known to be in progress, including use of deadly force as a result of force protection. (Examples include force protection of convoy vehicles or vessels not on installations.)

(6) Major Fire Onboard a Non-Nuclear Powered Warship. A major fire declaration indicates that the fire has exceeded or is anticipated to exceed the ship's force's ability to fight the fire and additional shore-based assets may be required. (A multi-level fire is a major fire.)

property damage, significant mission degradation, or requires immediate response by a NAVSUPPACT Naples asset. Incident will also be reported in accordance with reference (e) and (f). (Examples include earthquake, tsunami, significant weather event, fire, flooding, hazardous material (HAZMAT) release, pandemic situation, sortie of ships or aircraft, emergency evacuation, or volcano eruption.)

(9) <u>Critical Injuries or Death to NAVSUPPACT Naples Personnel</u>. Any occurrence resulting in critical (life threatening or loss of limb, shooting, stabbing, knocked unconscious), resuscitation attempt of (cardiac/respiratory arrest or any incident where an Automated External Defibrillator (AED) was applied), or death to personnel assigned to NAVSUPPACT Naples (to include dependents, civilians and contract personnel). Reports are NOT required for hospitalized individuals when death involves either natural causes or war-related injuries. (Unless positive identification is deemed necessary, utilize generic identification such as "PO1" or "20 YR-OLD FEMALE E-3" in reporting)

(Examples include RFI's from CNIC, EUCOM, COMNAVEUR, COMNAVAF, COMNAVCENT, COMSIXFLT) Request for Support (RFS) or RFI from a Region installation or operation forces which requires an immediate response. (For example, aircraft request to land on NAVSUPPACT Naples.)

Final report – CCIR will be closed once a response has been provided.

(11) <u>Degradation of Operational Capability</u>. Any significant unscheduled closure, restriction, or reduction in NAVSUPPACT Naples activities ability to conduct its mission or support operation forces. (Examples include runway (approach lighting) or port (pier damage) reduction in operations, loss of force protection capability (final denial barrier), reduction of fire and emergency services capability (fire trucks/fire main pressure), any unscheduled non-availability of Region aircraft etc.)

(13) <u>Active Media Coverage</u>. Any incident involving a NAVSUPPACT Naples activity or personnel that has generated negative international or national media coverage that could cause significant embarrassment to the Navy or higher-level Navy interest.

The NAVSUPPACT Naples CDO will report the following CCIRs electronically via email to NAVSUPPACT Naples CO, NAVSUPPACT Naples XO, NAVSUPPACT Naples OPSO and NAVSUPPACT Naples CMC with minimal delay. When applicable, include other NAVSUPPACT Naples N-codes and/or Special Assistants. For the CCIR e-mail report template, see enclosure (2).
- (1) <u>Media Interest</u>. Any incidents involving a NAVSUPPACT Naples facility or personnel, that is anticipated to generate negative international, or national media coverage, could cause significant embarrassment to the Navy, or will generate Naval Component Commander or higher-level Navy interest.

reference (a), which occurs at NAVSUPPACT Naples or in the NAVSUPPACT Naples AOR or any incident (e.g. fire, flooding, earthquake) causing significant damage (\$500,000 or more) which occurs on a NAVSUPPACT Naples facility, not reported as a CAT I CCIR.

Suspicious activity CCIRs can be updated and changed to Operational Surveillance once qualified authority (i.e. NCIS or other credible intelligence sources) has deemed it appropriate.)

Any incident which is reportable per reference (a) as an OPREP-3 UNIT SITREP involving personnel assigned to NAVSUPPACT Naples or Tenant Commands based within the NAVSUPPACT Naples AOR. Any OPREP-3 regarding sexual assault will be reported using CCIR for sexual assault.

(6) <u>Service Interruption</u>. Any unplanned service interruption or disruption of normal installation activity. (Examples include loss of power, water, use of building or housing, network and software outages including ONE-NET services, C4I outage, etc. in excess of one hour. Also, report interruptions of dispatch service and other Public Safety Network (PSNet) services such as Enterprise Land Mobile Radio System (ELMR), crash phone, giant voice announcement systems, fire and security alarm systems, and fire and emergency services.)
