

### COPS AND LOLLIPOPS

- While traveling throughout Italy, you may come across a police checkpoint that requires you pull over to the side of the road for inspection.
- Law enforcement officers may or may not be in uniform. In major cities, undercover police officers are frequently seen, often driving off-road motorcycles or unmarked vehicles.
- These officers are authorized to use stop signs, which due to their distinctive shape are commonly referred to as "lollipops" It is important to note, that during these interactions, you will typically see two officers: one stopping the vehicle and the other providing cover to ensure the smooth progression of traffic.
- In the event that you are stopped, it is essential to be prepared to show the following documents:

#### Driver License while stationed overseas

- Unfortunately, there is no agreement in place for the reciprocal recognition of driver's licenses between Italy and the United States
- The MVRO-issued driver license is only valid for driving in Italy. Individuals planning extensive travel throughout the European theater are strongly advised to obtain an International Driving Permit.
- Visiting family members/friends are NOT authorized to drive an MVRO registered vehicle, they can only drive a rental car provided they have an INTERNATIONAL DRIVER LICENSE

### DRIVING UNDER THE INFLUENCE

### **DUI** intoxication levels

- A)
  From 0,5 grams to 0,8 grams per liter, citation will range from 543 to 2170 euro, driver license will be suspended for a period ranging from three to six months.
- B)
  From 0,8 grams to 1,5 grams per liter, citation will range from 800 to 3.200 euro, driver license will be suspended for a period ranging from six months or up to 1 year.

  This level of intoxication can also result in DETENTION for up to six months.
- C)
  Level of intoxication above 1,5 grams per liter, citation will range from 1500 to 6000 euro. Driver license will be suspended for 12 months to 24 months.

  This level of intoxication can also result in DETENTION ranging from six to twelve months.

If you refuse to be tested from the Italian authorities, category C will be applied by default



## TRAFFIC ACCIDENTS

- >Turn on your hazard lights.
- Put on your reflective vest (better to have multiple vests in the vehicle) if the IT authorities are not going to respond, vehicles (if drivable), can be moved to a safe spot, make sure to take plenty of pictures before you move the vehicles.
- >Please utilize Road Hazard Warning Triangle
- Call the NON Emergency Dispatch line at +39 081-568-5638 or 5639
- Be respectful to host nation response personnel, they are there to assist you.
- Be prepared to exchange insurance & POV information with other drivers.
- You are allowed to take pictures of the traffic accident scene.



### TRAFFIC ACCIDENT WITH INJURIES

Contact Emergency Management + 39 081 568 4911

If you are injured in the course of a traffic accident, you will be transported to an Italian hospital by Ambulance.

If you decline medical treatment at the scene, you will be required to sign a ''Medical Attention Denial'' form/waiver. Otherwise, you will be treated.

Depending upon the severity of injuries and/or vehicle damage, your POV may be seized for evidence. Upon your arrival at the IT medical facility, IT authorities can request for you to provide a blood/urine sample or request for you to submit to a breathalyzer test on the scene of the traffic accident.

• If you decline to be tested, your driver's license will be seized and suspended immediately, your vehicle will be placed under indefinite seizure, meaning it will not be returned to you. Additionally, you will be charged with violating art. 186-bis/C for driving under the influence



#### SWINDLES AND EXTORSIONS WHILE ON THE ROAD

As you are driving and going about your business, someone will attempt to lead you to believe that you have just damaged their vehicle. They may honk, signal with their headlights, or even attempt to pull you over. If you are 100% sure that you did not make contact with the other vehicle, it is advisable to continue driving. If possible, contact Emergency Management and take a photograph of the other vehicle's license plate. These individuals will attempt to create an emergency situation to extort money from you. These individuals will often use family members, such as a female and a child, in their vehicle to manipulate drivers into pulling over.



### RESIDENTIAL CRIME PREVENTION - I

Your crime prevention plan begins <u>NOW</u> as you are house hunting.

When selecting a residence, it is important to prioritize security. Ensure that you understand how to operate the house alarm system. For off-base residences, alarm contact sensors for doors and windows are essential, as well as motion detectors. Prior to signing a lease, it is important to exercise your leverage with your potential landlord.

When negotiating the terms of a lease, it is advisable to consider any potential upgrades to the security features of your residence. Prioritize the installation of door and window contact sensors and motion detectors, as these are essential for ensuring the safety and security of your property. When contemplating these upgrades, it is prudent to consider the perspective of a potential intruder and assess the ease with which they could access your home.

All residential alarms consist of an internal/external siren and a main internal unit. It is advisable to have an alarm system with a phone dialer programmed to dial out for help. Additionally, for a monthly fee, the alarm system can be monitored by a company similar to ADT, which responds to the residence when the alarm is triggered by an intruder.



- >ALWAYS lock your doors and windows
- Test your alarm system at least once a month; request for your landlord to replace the batteries prior to moving into your new residence
- Ensure your alarm system allows for your pets to move freely throughout the residence.
- >PET FRIENDLY MOTION SENSORS, ask for it
- >Do not get comfortable with not having the alarm on
- >Motion sensor activated lights are a great deterrent
- Don't place keys/wallets/purses/backpacks by the front door.
- >ACTIVATE YOUR ALARM AT ALL TIMES



# HONEY, DID YOU HEAR THAT?

- >If someone breaks in your house...
- >DO NOT get in a physical confrontation, unless physically assaulted by the intruder.
- > Defense must always be equal/comparable to the offense.
- >YOU ARE NOT ALLOWED TO OWN NOR PURCHASE A GUN.
- Your alarm, door and windows, are your first line of defense, put'em to work...TURN YOUR ALARM ON @ NIGHT
- >YES, you are allowed to purchase pepper spray on the local economy.
