# ***COPS AND LOLLIPOPS***

- *As you are traveling throughout Italy, you may come across a police checkpoint requesting for you pull over to the side of the road for a check. Law Enforcement Officers, may or may not be in uniform. Major cities frequently utilize undercover police officers, who are known to drive off-road type motorcycles or unmarked vehicles. They carry hand-held stop signs that Americans, due to their shape nicknamed “lollipops”*
- *Usually you will see two officers: one with the “lollipop” and one providing cover to ensure that everything runs smoothly*
- *Once you get pulled over, be prepared to present the following:*

# ***DRIVING UNDER THE INFLUENCE***

## *DUI intoxication levels*

**A)**  
*From 0,5 grams to 0,8 grams per liter, citation will range from 573 to 2170 euro, driver license will be suspended for a period ranging from three to six months.*

**B)**  
*From 0,8 grams to 1,5 grams per liter, citation will range from 800 to 3.200 euro, driver license will be suspended for a period ranging from six months or up to 1 year. This level of intoxication can also result in DETENTION for up to six months.*

**C)**  
*Level of intoxication above 1,5 grams per liter, citation will range from 1500 to 6000 euro. Driver license will be suspended for 12 months to 24 months. This level of intoxication can also result in DETENTION ranging from six to twelve months.*

*If you refuse to be tested from the Italian authorities, category C will be applied by default*



# SMARTPHONES WHILE DRIVING

- *The latest edition of the Highway Code introduces more rigorous guidelines for the use of smartphones while driving. Furthermore, penalties will be more strictly enforced in cases of recidivism. A fine of €250 to €1,000 and a one-week license suspension, will be imposed on individuals found to be distracted by a smartphone for the first time.*
- *For repeat offenders, the fine will increase to 1,400 euros and the license suspension may extend up to three months. These penalties will be applied in addition to any other applicable penalties, such as those incurred for causing an accident while distracted by a smartphone, which would result in even more severe consequences.*



# ***TRAFFIC ACCIDENTS***



- ***Turn on your hazard lights.***
- ***Put on your reflective vest (better to have multiple vests in the vehicle) if the IT authorities are not going to respond, (if drivable), vehicles can be moved to a safe spot, make sure to take plenty of pictures before you move the vehicles.***
- ***Please utilize Road Hazard Warning Triangle***
- ***Call the NON Emergency Dispatch line at +39 081-568-5638 – +39 081 568-5639***
- ***Be respectful to host nation response personnel, they are there to assist you.***
- ***Be prepared to exchange insurance & POV information with other drivers.***



# ***TRAFFIC ACCIDENT WITH INJURIES***

- ***Contact Emergency Management + 39 081 568 4911***
- ***If you are injured in the course of a traffic accident, you will be transported to an Italian hospital by Ambulance.***
- ***If you refuse medical treatment on the scene, you will be expected to sign a “Medical Attention Denial” form/waiver.***
- ***Otherwise, you will be treated.***
- ***Depending upon the severity of injuries and/or vehicle damage, your POV may be seized for evidence. Upon your arrival at the IT medical facility, IT authorities can request for you to provide a blood/urine sample or request for you to submit to a breathalyzer test on the scene of the traffic accident.***
- ***If you refuse to be tested, your DL will be seized and suspended on the spot, your vehicle will be placed under indefinite seizure, meaning, your vehicle will not be returned back to you, you will also be charged with violating art. 186-bis/driving under the influence***



# ***MY CAR IS GONE, NOW WHAT?***



***Immediately notify Emergency Management +39 081 5685638 - 5639***

***Provide EM with your POV make, model and license plate.***

***A temporary APB/BOLO will be issued to the LEA.***

***I-7 personnel will assist you in filing a police report with the IT authorities. If you have full coverage, you will also need to bring a copy of your insurance contract. Your vehicle registration will also be needed.***

***Once we are done with the local authorities, the original police report for the vehicle theft must be turned over to MVRO.***

***Contact your insurance company and make them aware of the fact that your vehicle has been stolen.***



# ***AUTO CRIME PREVENTION***



## ***USE YOUR GARAGE***

*Always carry a spare set of house and car keys on your person or at a location that you can easily access, like your office, or a trustworthy neighbor.*

*Never EVER leave your house keys in the car*

*Remove items that could indicate that you're an American or that you belong to a "foreign" community.*

## ***SWINDLES AND EXTORTIONS WHILE ON THE ROAD***



*As you are driving minding your own business, someone will lead you to believe that you have just damaged their vehicle.*

*They will honk @ you, signal you with their headlights, motion you to pull over, sometimes they will aggressively pull in front of your vehicle in the attempt to make you pull over. If you are 110% sure that you did NOT touch their vehicle, just keep on driving.*

*Contact Emergency Management, if possible, take a picture of their vehicle, license plate is a MUST HAVE.*

*They will try their best to make you pull over a attempt to extort money from you.*

*The majority of the times they will have a female and a child in their vehicle to lower your level of alertness.*

# ***RESIDENTIAL CRIME PREVENTION - I***



***Your crime prevention plan begins NOW as you are house hunting.***

***Be smart when choosing a home and ALWAYS keep security in mind.***

***Make sure that you understand and are able to operate the house alarm***

***Alarm contact sensors for doors and windows, as well as motion detectors are required for off-base residences.***

***Prior to the lease signing is when you have the most leverage with your potential landlord. If you want to upgrade any of the security features of your residence, now is the time to ask***

***Think like a crook, how easy would it be for you to get in your own house?***

***All residential alarms are composed of an internal/external siren and a main internal unit; alarm system with a phone dialer programmed to dial out for help are a must have. Alarm system may also be monitored by an ADT type company that will actually respond to the residence when the alarm is triggered off by an intruder.***



# ***RESIDENTIAL CRIME PREVENTION - II***



- ***ALWAYS lock your doors and windows***
- ***Test your alarm system at least once a month; request for your landlord to replace the batteries prior to moving into your new residence***
- ***Ensure your alarm system allows for your pets to move freely throughout the residence. **PET FRIENDLY MOTION SENSORS**, ask for it***
- ***Do not get comfortable with not having the alarm on***
- ***Motion sensor activated lights are great.***
- ***Don't place keys/wallets/purses/backpacks by the front door.***
- ***ACTIVATE YOUR ALARM AT ALL TIMES***



# ***HONEY, DID YOU HEAR THAT?***



- ***If someone breaks in your house...***
- ***DO NOT get in a physical confrontation, unless physically assaulted by the intruder.***
- ***Defense must always be equal/comparable to the offense.***
- ***YOU ARE NOT ALLOWED TO OWN NOR PURCHASE A GUN.***
- ***Your alarm, door and windows, are your first line of defense, put'em to work...TURN YOUR ALARM ON @ NIGHT***
- ***YES, you are allowed to purchase pepper spray on the local economy.***
